

## **Financial Documents Required**

International students planning to enroll on a student (F-1) visa must complete the **International Student Information Form** and provide proof of financial support. Financial support may be obtained from more than one source, and documentation can be no more than six months old. Before an I-20 Form will be issued, the student must be admitted to the university and provide assurance that sufficient financial resources are available to cover the costs of the first year of study and that adequate funding will be available for subsequent years.

## **Issuance of a Nonimmigrant Student Visa**

**(F-1)**

Once a student has been admitted to the university and provided acceptable proof of funding, the Office of International Student Services will review the documents provided and issue the appropriate immigration document. (Form I-20) This form needs to be taken to the U.S. embassy or consulate to apply for the appropriate visa. Students already in the United States should contact ISS for instructions on transfer procedures of their immigration status and/or change of status, if necessary.
