Biological and Computational Sciences

Effective Fall 2017, the following programs have been placed on hiatus: BA in Mathematics, BA in Mathematics with Secondary Education, and Secondary Education Certification: Math. No new students will be admitted into these programs. (Approved April 25, 2017)

Business and Accounting

Effective Fall 2017, a major in Business Leadership is available to students in the College of LifeLong Learning. Required courses in the Business Leadership program include: BUS 308; BUSL 375, 377, 378, 393, 394, 395, 396; CCS 341; COM 355; ECO 323, 344; ENG 242; FIN 373; HRM 376; MKT 310; PHI 384; THE 335 or 381 (Approved May 31, 2017)

Education

Effective Fall 2017, the requirements for the BA in Education and all majors that include teacher certification have been changed to eliminate EDU 301 and EDU 393. Student Teaching courses (EDU 348 and EDU 328) have been increased from 6 to 12 credits. Current students who have completed EDU 301 or EDU 393 should contact their academic advisor. Interactive Digital Media

Effective Spring 2017, the Interactive Digital Media major has moved from the Biology, Data Systems and Mathematics department to the English/Communication department. (Approved March 23, 2017)

School Nurse Certification Program

Effective Spring 2017, the School Nurse Certification program has been placed on hiatus. No new students will be admitted into this program. (Approved January 17, 2017)

Nutrition and Dietetics

Nutrition – Didactic Program in Dietetics

Effective Fall 2017, the program requirements for this major are updated as follows:
