

POINTS OF PRIDE

Immaculata is recognized for the valuable education it provides, for its student retention rate, for the median salaries of its alumni and for the overall return on investment the University offers.

STRATEGIC ENROLLMENT & ACADEMIC PROGRAM INITIATIVE HIGHLIGHTS FOR 2023–2024

To provide the best possible educational experience, Immaculata University offers academic majors and co-curricular activities that are most in-demand for today's students.

Partnerships

- » IU partnered with Thomas Jefferson University to offer a pathway to achieve a Master of Science in Emergency & Disaster Management for IU undergrads in the emergency planning & management program.
- » IU and CCRES Educational and Behavioral Health Services entered into an agreement that offers tuition discounts to CCRES employees for both undergraduate and graduate degrees.
- Immaculata partnered with Penn State Great Valley (PSGV) to offer its M.S.N. in Nursing Informatics while IU students can earn a graduate certificate in analytics for managers from PSGV.
- » IU has new dual enrollment partnerships with Downingtown School District, Chester Upland School District, Lancaster Catholic, Spring Ford School District and Marple Newtown School District.

Academic Program Enhancements

- » New Master of Science in Nursing for Family Nurse Practitioner
- » New Master of Science in Criminal Justice
- » New Associate of Arts in Social Sciences
- » New Bachelor of Science in Esports and Business Management
- » New undergraduate certificates in Music Performance and Applied Politics
- » New undergraduate minor in Emergency Management

Strategic Enrollment Initiative Highlights

- » The College of Nursing and Health Professions launched in fall 2023.
- » Immaculata hosted over 200 high school students through competitions, Chester County Intermediate programs and the Honors Band and Chorus.
- » After Cabrini University announced its closure after the 2023–2024 academic year, Immaculata created straightforward transition pathways for Cabrini students to IU.
- The Atlantic East Conference, in partnership with the NFL and RCX Sports, along with support from the Philadelphia Eagles, announced its plan to be the first NCAA conference— Division I, II or III—to offer varsity female flag football with an anticipated start date of spring 2025.
- » Immaculata unveiled an updated website that focuses on the needs of potential students by improving user experience and site navigation.

» IBX Foundation awarded a grant to create a Collegiate Recovery Program, directed by graduate faculty members of IU's Psychology and Counseling Department.

IMMACULATA'S GREATEST PRIORITIES

Academics

Generosity to this area will assist our outstanding faculty and staff in their work to develop leading-edge academic programs and resources for our students at the undergraduate and graduate levels. Immaculata's programs are rooted in academic rigor, ethical integrity and Christian core values and encourage a commitment to lifelong learning and professional excellence. Personalized academic attention is the hallmark of Immaculata's programs.

Athletics

Support to this area will impact our 200+ varsity studentathletes and 21 intercollegiate NCAA Division III men's and women's varsity teams. The University also sponsors a co-ed esports varsity team and several intramural programs. Athletics is an integral part of the educational experience at Immaculata University. The specific aim of Immaculata athletics is to provide a quality competitive experience in an atmosphere of commitment, success and teamwork.

Scholarships

Almost 20% of the University's operating budget is allocated to student grants and scholarships. Scholarship support assures that future Immaculata students will enjoy the same educational opportunities as did past generations.
